

- 1) **Contest Details and Concept:** The Weikfield Pasta Khao Italy Jao ("**Contest**") is a consumer promotion launched by Weikfield Foods Pvt. Ltd., ("WFPL") where individuals have the opportunity to win Play station, HCL Tablets, Digital cameras, MP3 players and a trip to ITALY by participating in and completing ("Collect the letters I, T, A, L, Y,"), make a slogan and answer the questions.

The Contest is promoted, *inter alia*, through, contest TVC spots, point-of-sale material, outdoor advertisements, print advertisements, and the website www.weikfield.com & Face book page ("**Contest Website**"). The Contest is subject to all applicable central, state and local laws and regulations.

A. How to Enter the Contest "Pasta Khao ITALY Jao", Entry Form Route:-

- I. Collect the Letters Component of the contest: As a first step, Participants are required to buy Weikfield Pasta packs containing letters inside the pack. Collect five packs each containing one printed letters I, T, A, L & Y, Letters may be found printed at inside portion of the pack of selected (a) Weikfield Pasta 500g: Penne, Elbow, Spaghetti (b) Weikfield Pasta 200g: Penne, Elbow, Fusilli, Shell and (c) Weikfield Pasta 50g: Penne (excluding institutional packs). And complete the sequence ITALY and stick each letter on the space provided in "Weikfield Pasta Khao Italy Jao" Contest entry form.
- II. Answer the Questions Component of the contest: As second step, Participants are required to answer the questions given in the entry form.
- III. Make a Slogan: in make a slogan component of the contest, participants are required to write a Slogan not more than 20 words on "why do they like weikfield Pasta", in the entry form.
- IV. Entry Form: Contest entry form is available inside weikfield 500gms pasta packs or one can download the entry form, from our website www.weikfield.com and fill in the entry form with participant details and complete the entry form as per above mentioned steps in order to participate in "Pasta Khao Italy Jao Contest"

Please note that all Participants are required to preserve the original pasta pack from which letters ITALY are cut and sent to WFPL address provided.

B. Selection of Best entries and Prizes:-

- I. Best Entries Selection: A Panel of Judges appointed by WFPL will conduct the selection of best entries to generate the winners and their decision stands final. The procedure for selection of winners for the Collect the letters ITALY: WFPL will transmit all valid entries submitted during Contest period to the Panel of Judges (appointed by WFPL). The Panel of Judges shall select one hundred and fifty Participants based on best slogan, correct answers and Valid Entries received at the end of the contest. The selected Participants become eligible to receive the following prizes:
 - a. **Grand First Prize Trip to ITALY:** One best entry selected first will receive the grand prize i.e. Travel package to Italy for one person.
 - b. **Second prize:** 2 participants selected will get one play station each.
 - c. **Third prize:** 5 participants selected will get one HCL tablet each.
 - d. **Fourth prize:** 10 participants selected will get one 8 mega pixel digital camera each.
 - e. **Fifth prize:** 25 participants selected will get one MP3 player each.
 - f. **Sixth prize:** 57 Participants selected will get one Weikfield bag each.
 - g. **Consolation prize:** 50 Participants will be selected for one consolation prize each.

- 2) Contest Period and validity: This Contest will commence at 10:00am Indian Standard Time (IST) on 1st July 2013 ("**Start Date**") and will continue until 31st Jan 2014 ("**End Date**") 6:00pm IST ("**Contest Period**"). The valid timings for receiving entries for the Collect the letters in the pack are between 10:00 AM and 6:00 PM each day of the Contest Period ("**Contest Timings**"). Please note that the Contest Timings will be determined in accordance with IST.
- If an entry is received either before the commencement of, or after completion of the Contest Period, the Participant will receive a message requesting him/her to apply during the appropriate period and time.
 - If the Participant sends an entry outside the Contest Timings i.e. any time after 6:00 PM or before 10:00 AM, he/she will receive a response the next day confirming the receipt of the entry.
 - If the Participant sends an entry which is not in the prescribed format, or contains an invalid pack with the letter he/she will receive an SMS/email informing him of the required format along with a request to reapply.
 - If the Participant sends a valid entry in the prescribed format, he/she will receive a message confirming his entry in the Contest ("**Valid Entry**")
 - Only a limited number of Packs, as determined by WFPL at its sole and absolute discretion, will be available for distribution during the Contest Period. Therefore, neither WFPL nor the Agents represent or warrant that every person making a purchase during the Contest Period will be entitled to a Pack containing one letter I, T, A, L & Y. Pasta packs with letters will only be provided until stocks last. No claims or complaints may be raised against WFPL or the Agents in this respect.
 - Further, Consumers acknowledge and understand that there may be Pasta Packs containing letters and entry form inside the packs may be available for sale even after the end of the Contest Period; however, Consumers will not be entitled to participation in the Contest at that time. Consumers agree not to make any claim or raise any complaint against WFPL or its Agents in this respect.
- 3) Deemed acceptance of Terms and Conditions: Entry and participation in this Contest is deemed unconditional acceptance of these terms and conditions including any modifications thereto. Successfully entering the Contest and winning a prize is subject to all requirements set forth herein. The decisions of Weikfield foods Pvt. Ltd. are final and binding in all matters related to the Contest. WFPL reserves the right to amend, modify these terms and conditions at its sole discretion without any prior notice to the Consumers. WFPL also reserves the right to cancel or terminate the Contest at any stage without assigning any reasons whatsoever.
- 4) Promoter and its Agents: Weikfield Foods Private Limited having its corporate office at Weikfield IT City Info park, "D" Block, 9th Floor, Nagar Road – Pune 411 014, Maharashtra, India, shall be the "**Promoter**" of this Contest.

The "**Agents**" are: A reputed travel agency, determined by WFPL at its sole and absolute discretion ("**Travel Agency**"), which shall manage certain pre-designated travel related logistics, including but not limited to planning an itinerary, making airline and hotel reservations.

- 5) Eligibility: *Collect the letter inside the WFPL pasta pack, make a slogan and answer the questions*: Entry and participation is open to Indian citizens currently residing in any Indian state with the exception of the state of **Tamil Nadu and aged 18 years or above who satisfy the following criteria.**

Following are not eligible to participate in the contest: management, employees, directors or contractors, or the family of the management, employees, directors or contractors of WFPL or the Agents, their related entities or other agencies, firms or companies associated with the Contest (including suppliers of prizes).

For the sake of clarity, the Collect the letters (I, T, A, L, Y), make a slogan and answer the questions Component of the Contest is not open to Non-Resident Indians (NRIs), Overseas Citizens of India (OCIs) and Persons of Indian Origin (PIOs). Eligible Persons participating or seeking to participate in the Contest shall individually be referred to as "Participant" and collectively as "Participants".

6) Grand Prize : Only one winner

- a. Eligibility
 - I. Must have a valid passport which shall not expire before December 31, 2013 (only in case of winners of the Grand Prize)
 - II. Must have not been arrested for or convicted of any crime or been the subject of any criminal investigation.
 - III. Bear a good moral character and have not been implicated or named in any legal proceedings (either Civil or Criminal).
- b. Inclusion for grand prize winner(trip to ITALY) only for one person
 - I. Visa application fee.
 - II. Round-trip air transportation from the port of departure selected by WFPL to ITALY, on an airline selected by WFPL/ the Travel Agent.
 - III. 3 days 4 nights stay in 3 or 4 star hotel selected by WFPL.
 - IV. Ticket to watch selected shows or sites in Italy, selected by WFPL at its sole and absolute discretion.
- c. Not included:
 - I. Transportation costs associated with submitting any visa documents, attending the visa interview and/or collecting the visa.
 - II. Costs incurred in travelling from the Participant's city of residence to the port of departure, and from the port of departure back to the Participant's city of residence (if applicable).
 - III. Travel insurance (mandatory), other taxes, extra meals, transfers, gratuities, souvenirs, fuel surcharges, port charges, and any other incidentals.
 - IV. Any other incidental cost, including baggage costs, not expressly included above.
- d. Terms and conditions for Grand Prize winner:
 - i. The Prize is ex-Mumbai Airport. However, WFPL reserves the right to alter the port of departure and return.
 - ii. The Confirmed Winner agrees to bear the cost of travelling from the city in which he/she resides to the port of departure prior to departure and from the port of arrival (upon returning to India) to his/her city.
 - iii. If the Confirmed Winner, for any reason whatsoever, is unable to board the designated flight to Italy such Winner's Prize shall stand forfeited. If the Confirmed Winner fails to board the return flight from Italy to India, the Winner will be required to return at his/her cost and neither WFPL nor the Travel Agency shall be liable for any claims, damages or liabilities arising there from.
 - iv. Travel arrangements will be made by the Travel Agent, on a carrier of Travel Agent/WFPL's choice. Flight schedules are subject to change without notice. All travel is subject to availability of tickets.
 - v. Winner must travel on the itinerary and date(s) chosen and declared by WFPL at its sole and absolute discretion. WFPL also reserves the right to alter the chosen dates of travel or the itinerary of travel, at its sole and absolute discretion. In the event any Confirmed Winner is unable to travel on the designated date(s), his/her prize shall be forfeited. Further, WFPL may, at its sole and absolute discretion, require the Confirmed Winners to travel in a group, or individually.
 - vi. Confirmed Winners are responsible for any additional spending on meals (other than those included as specified in clauses 5 and 8 above) and any other ancillary costs, including but not limited to insurance, any applicable insurance excesses, excess travel luggage and payment in respect of any damage to property or person caused by the Confirmed Winners. It is the Winners' responsibility to organise transport to/from the airport departure/return point. Winners must have valid travel insurance for their period of travel.
 - vii. No portion of the Grand Prize is redeemable for cash. The Grand Prize is not refundable or transferable.

- viii. Confirmed Winner is responsible for obtaining all required travel documents prior to travel.
 - ix. The Confirmed Winner further undertakes that he shall be solely responsible for his conduct (his actions and inactions) during the period of travel.
 - x. Further, the Confirmed Winner agrees to release, discharge and hold harmless WFPL and its partners, affiliates, subsidiaries, advertising agencies, agents and their employees, officers, directors, and representatives from any claims, losses, and damages arising out of his/her conduct during participation in the Contest and travel as part of the Contest.
- 7) Contacting winners: The Eligible Winners will be contacted by WFPL as per the procedure outlined below:
- I. WFPL will call each of the Eligible Winners on the mobile number provided by the Eligible Winner at the time of entering the Contest, within forty-eight (48) hours of their selection.
 - II. In the event an Eligible Winner is not interested in continuing in the Contest, the caller will inform the Participant that they have effectively forfeited their Prize. An SMS/Email confirming the forfeiture will be sent to such Eligible Winner.
 - III. In the event the Eligible Winner is not reachable, two more attempts will be made to call him on the same day. If even after a total of three attempts, the Eligible Winner is not contactable, or is contacted and mentions that he/she is not interested in continuing in the Contest, the Eligible Winner will be informed that his/her prize has been forfeited. An SMS/Email confirming such forfeiture will be sent to such Eligible Winner.
 - IV. In the event the Eligible Winner is busy, the caller will request the Eligible Winner to suggest a good time to call on the same day or the next day, during regular working hours. If the Eligible Winner is still busy, or unreachable, or not interested, his/her prize shall be forfeited and an SMS confirming forfeiture will be sent to the Eligible Winner
 - V. In the event of occurrence of a situation described in points (ii), (iii) or (iv) above, a second draw will be conducted in accordance with the procedure outlined in Clause below.

In the event that the Eligible Winner is contacted and interested in continuing in the Contest, the following procedure will apply:

- I. The Eligible Winner: the participant will be informed about his prize.
- II. If an Eligible Winner states that he/she does not have a valid PAN card, the Eligible Winner's prize shall stand forfeited. The Eligible Winner shall receive an SMS confirming the same.
- III. If an Eligible Grand Prize Winner states that he/she does not have a valid PAN card and/or a valid passport that does not expire prior to December 31, 2013, the Eligible Winner's prize shall stand forfeited. The Eligible Winner shall receive an SMS confirming the same.
- IV. If the Eligible Winner provides accurate details and has a valid PAN card and/or passport (as applicable), he/she will be requested to submit the following documents by Registered Post Acknowledgment Due within **fifteen (15) days** to "Weikfield Pasta Khao Italy Jao Contest" :
 - a) Information Letter (as per Annexure 1)
 - b) Consent Letter to the Terms & Conditions of the Contest duly signed by the Eligible Winner (as per Annexure 2)
 - c) The following documents that are *self-attested* for the purpose of taxation and legal validation:
 - 1. Photocopy of Permanent Account Number card
 - 2. Photocopy of government approved address proof (Voter's ID card, Driver's License, etc.)
 - 3. Photocopy of Photo ID proof (Driver's License, PAN Card, etc.)
 - 4. Photocopy of Bank account details (passbook, a cancelled cheque, etc.)

5. A self-attested photocopy of each page of the Eligible Winner's Indian passport (Applicable only to Eligible Grand Prize Winners)

6. ("**Required Documents**")

- V. Once the documents submitted are validated, in case of a Prize winner, WFPL shall issue a Congratulatory Letter (Annexure 3) and a No-Claims Letter (Annexure 4) to, along with the prize within 90 days of the end of the Contest Period. The Eligible Winner will have to sign the No-Claims Letter and return it to the courier, without which he/she will not be able to collect his prize.
- VI. In case of a Grand Prize winner, WFPL shall issue a Congratulatory Letter, a No-Claims Letter and a Declaration, Waiver of Claims and Indemnity (Annexure 5). The No-Claims Letter and the Declaration, Waiver of Claims and Indemnity Document shall be signed and returned by the Eligible Winner to WFPL and upon receipt of these documents, the Eligible Winner shall be designated the "**Confirmed Winner**". The Eligible Winner shall not be entitled to receive his/her prize unless the required documents are submitted within the timeline established by WFPL.
- 8) Second draw: If any of the Eligible Winners effectively forfeit their prize, the Panel of judges shall conduct up to one more entry selection to select the Eligible Winner. The process outlined in clause 9 above will apply. However, if the Eligible Winner selected in the second draw is not interested, not reachable or busy, no further draw will be conducted to select winners, and no winner will be declared for that hour(s), leaving the slot vacant.
- 9) Reminder: If the Eligible Winner fails to submit the Required Documents within the fifteen (15) day period, commencing from the date on which the Eligible Winner receives a call from WFPL, or submits incomplete or illegible documentation, WFPL shall call the Eligible Winner a second time and remind him/her to submit complete documentation. Simultaneously a Final Reminder Letter (Annexure 5) shall be sent to the Eligible Winner giving him/her an additional seven (7) days to submit the Required Documents via Registered Post Acknowledgment Due. If the Required Documents (in complete and legible form) are not received within seven (7) days of receipt of the Final Reminder Letter, the Eligible Winner will be sent an SMS confirming that his/her prize stands forfeited and his/her entry in the Contest stands cancelled. No justification/explanation for non-receipt of Required Documents shall be accepted, including but not limited to, inability of the postal department to deliver the documents on time.
- 10) Handing over of information to the Travel Agent: Grand Prize winners Once WFPL receives all the Required Documents from the finalized winners of the Grand Prize, the relevant documents will be handed over to the Travel Agent which will assist the finalized winner in applying for a visa for travel to Italy.
The finalized winner will be required to adhere to the instructions of the Travel Agent in completing the visa application. The visa application fee shall be paid by the Travel Agent or WFPL on behalf of the finalized winner.
Please note that apart from the visa application fee, neither the Travel Agent, nor WFPL or other Agents of this Contest will be responsible to bear any other costs in relation to procurement of visa, including but not limited to the following:
- Travel for the purpose of meeting the Travel Agent
 - Travel for the purpose of the visa interview
 - Travel for the purpose of collecting visa or submitting documents
 - Any other expenditure incidental to applying for or collecting the visa including but not limited to, accommodation, etc.
 - Cost of postage to send required documents?

The finalized winner understands and acknowledges that neither the Travel Agent nor WFPL or Agents of this Contest are responsible for:

- Any delay in procurement of the visa;
- Inability to procure visa; or
- Rejection of a visa application by concerned authorities for any reasons whatsoever.

The finalized winner understands and acknowledges that his/her Prize will stand forfeited and his/her participation in the Contest will stand cancelled:

- If his/her visa is rejected by the concerned authorities; or

- If his/her visa does not come through on or before 30 Sep 2014

 - I. Consumers are not bound in any manner to participate in this Contest.
 - II. Participant warrants that all information provided by him/her regarding his/her name, age, state, city, address, phone number, etc., is true, correct, accurate and complete.
 - III. WFPL may, at any time, verify or authorize verification of the Participant's entry (including such Participant's identity, age, place of residence and affiliations) and disqualify any Participant (at any stage of the Contest) if it is found that such Participant has submitted an entry or any documents that is inconsistent with these Terms and Conditions.
 - IV. The Prize cannot be exchanged and is not transferable. Also, the prize is not convertible to either cash or any monetary benefits in kind.
 - V. WFPL accepts no responsibility for late, lost, incomplete, incorrectly submitted, delayed, illegible, corrupted or misdirected entries, pack with letters inside, documents, demand drafts, claims or correspondence whether due to error, omission, alteration, tampering, unauthorized data hacking, deletion, theft, destruction, virus attack, transmission interruption, communications failure, hardware failure or otherwise. WFPL shall not liable for any consequences of user error including (without limitation) costs incurred.
- XIII. If a Participant is dissatisfied with the Contest or the Contest terms and conditions, his/her sole and exclusive remedy is to not participate in the Contest.
- XIV. The general terms and conditions and privacy policy on the Contest Website shall be applicable in addition to these terms and conditions.
- XV. Neither WFPL nor its Agents shall be required to publish or disclose any personal details about the winners of the Contest (excluding the names of the winners which shall be published on the Contest Website), including but not limited to their telephone number, address, etc., as such disclosure shall amount to violation of the privacy rights of winners.
- XVI. Each Participant affirms that he/she is not a minor and is fully able and competent to enter into the terms, conditions, obligations, affirmations, representations, and warranties set forth in these terms and conditions, and to abide by and comply with these terms and conditions.
- XVII. These Terms and Conditions may be altered by WFPL at its sole and absolute discretion and without any notice to Eligible Persons and/or Participants.
- 14) Release and limitation of liability:
- (i) By participating in this Contest, the Participant agrees (a) to be bound by these Terms and Conditions, the decisions of WFPL and the final winner selection procedure(s), which are final and binding in all respects, and (b) to hold WFPL and its parent company, affiliates, subsidiaries, advertising and promotion agencies, and their respective directors, officers, employees and agents harmless against any and all claims and liabilities arising, in whole or in part, directly or indirectly, out of or in connection with participation in this Contest. WFPL may disqualify (and void all associated entries) any one from participating in the Contest if such person is suspected of or found cheating or adopting other unfair practices, or intending to annoy, abuse, threaten or harass any other Participant or WFPL's representatives or who is otherwise not in compliance with these Terms and Conditions.

- (viii) WFPL shall not in any way be liable for any disruption in or disconnection of the telephone line and all such disputes shall lie with the telecom service provider and not with WFPL. Proof of messaging is not proof of receipt.

- 15) Dispute: The courts of competent jurisdiction at Pune shall have exclusive jurisdiction to determine any and all disputes arising out of, or in connection with, the Contest. Participation in the Contest is unauthorized in any jurisdiction that does not give effect to all provisions of these terms and conditions, including without limitation this clause. Further all issues and questions concerning the construction, validity, interpretation and enforceability of these Terms and Conditions, or the rights and obligations of the Participants and/or WFPL and/or or Agents of this Contest, shall be governed and construed in accordance with the laws of the Republic of India.
