

TERMS & CONDITION FOR

Celebake with Vikas Khanna

These Terms and Conditions prevail in the event of any conflict or inconsistency with any other communications, including advertising or promotional materials. Entry/claim instructions are deemed to form part of the terms and conditions and by participating all participants and claimants will be deemed to have accepted and be bound by the terms and conditions.

1. Before participating in the contest, please read the terms and conditions given herein. By participating in the contest, each Participant is deemed to have accepted the complete terms and conditions of this contest available on Weikfield Foods Private Limited (WFPL or Weikfield) website as well as the decisions of WFPL, which are final and binding in all matters related to the contest.
